

PRIVACY STATEMENT

Social Impact Ventures NL

We are Social Impact Ventures NL BV, a team of enthusiastic impact investors with a mission to help entrepreneurs who demonstrate that social impact and healthy returns go hand in hand.

Privacy statement

In this privacy statement you read about the way your personal data is collected and how it is handled. This explains where your data is stored and for what purposes your data is stored. In addition, you will also find all your rights with regard to your data and how you can make use of these rights.

This privacy statement applies to our website www.socialimpactventures.nl (the "Website") and the communication we offer (the "Communication"). We treat your personal information in accordance with the General Data Protection Regulation (the "Relevant Legislation").

Personal data

We process personal data for (our Website and) Communication. The term "personal data" refers to information with which you can be identified as a person. This definition is in accordance with the relevant Legislation.

Your permission

We may store your data at different times, such as when you visit our Website and approach us in response to this, use our Communication (eg News items) or if you contact us. We may process your data because we request your consent through this privacy policy.

Furthermore, we will not process your data without your permission, unless we are legally obliged to do so.

What information do we collect, why, and what do we do with it?

To use our website and services we need the following information from you:

- Your name
- Your phone number
- Your e-mail adress
- Information about your company or product

We keep this information for the following reasons:

- (1) we like to keep you informed of what is happening with Social Impact Ventures and the investments we make,
- (2) we want you to share from time to time what we learn on our journey to make the world a little better with every investment, and
- (3) We like to hear what you think is right or wrong and how we can become better at what we do.

We also collect some information from you when you visit our site. Through google Analytics cookies we process personal data from our website visitors, because we want to know which pages visitors read. This to improve our website.

We have set up Google Analytics cookies as follows: We have signed a processor agreement with Google whereby the IP address is masked. We have also disabled data sharing and do not use other Google services in combination with the Google Analytics cookies.

We will only use your data for the above purposes, or for a goal that is closely related to this, but will never share these commercially with third parties.

Security

We make every effort to protect your personal information against loss, destruction, use, modification or distribution of your personal data by unauthorized persons. Because of this, those who have nothing to do with your data can not join.

We do this through the following measures:

Our website is hosted by a host based in the Netherlands, under the European privacy legislation. Our page is loaded via HTTPS and is protected by security of network connections with Secure Socket Layer (SSL), SSL certificate according to the new legislation.

- Our computers are protected with a password
- Access to the data is limited to those who need the data
- The programs we work with comply with the applicable data protection legislation. The programs are protected with a password and two step verification. Furthermore, almost all servers are located in Europe. If a server is not located in Europe, but in America, it complies with EU-US Privacy Shield.
- We only retain the necessary data, the rest of the data we will destroy.

And finally we use the Mailchimp program when sending our news items. Mailchimp is based in US and has adopted the EU-US Privacy Shield agreement for the exchange of personal data.

Storage period

We will not keep your personal information longer than we need it for the purposes we described earlier. If we enter into an agreement, this retention period will be a maximum of 7 years. If you stay informed through a newsletter and you want to unsubscribe, we will keep your data for maximum 7 years.

With whom do we share your personal information?

Processors

It may happen that other parties ("Processors") receive your data from us, but only with the same purpose as described above. We agree with these parties in a processor agreement that they handle your data carefully and they only receive the data necessary to provide their service. These parties only use your data in accordance with the instructions we give and not for your own purposes. We can, for example, pass on your details to a party that helps us to send a better newsletter. These parties are "processors" in the sense of the Relevant Legislation.

Transfer

We will only process your data within the European Union. Outside the European Union we only process your data if that country offers an adequate level of protection for your data. Without your permission, we will never pass on your details to other countries or to other parties than those mentioned above.

Links

Links can be found on our Website to other websites. We are not responsible for the content or privacy protection of these websites. We therefore advise you to always read the privacy policy of the relevant website.

Cookies

We may use cookies to see which pages of our site are read and consulted. Cookies also ensure, among other things, that the Website is fast, you can visit our Website safely and we can detect errors on our Website. We have set up Google Analytics cookies as follows: We have signed a processor agreement with Google whereby the IP address is masked. We have also disabled data sharing and do not use other Google services in combination with the Google Analytics cookies.

Change of privacy policy

We can adjust this privacy policy. If we change the privacy policy to a significant extent, we will post a notification on our Website together with the new privacy policy.

Your rights

If you are uncomfortable about the use of your data by Social Impact Ventures, please contact us. The information we collect from you is personal. You therefore have the following rights:

- You may ask us to view your data;
- You may ask us for correction, limitation or deletion of your data; Please note that if we have entered into an agreement, we legally have to retain certain data for 7 years.
- You may ask us for a copy of your data.
- You can object to the processing of your data;
- You can submit a complaint to the Dutch Data Protection Authority if you think that we are processing your data unlawfully;
- You may always withdraw your permission to process your data. From the moment you withdraw the permission, we may no longer process data from you.
